

## **EMPLOYMENT NOTICE FOR THE POSTS OF PEON AND SWEEPER**

Applications for twelve posts of Peon and one post of Sweeper in the Pay matrix of FPL-DL (Rs.16900-53500) plus other usual allowances, purely on temporary basis for Ambala Sessions Division are hereby invited from the general public. The essential qualification for the aforesaid posts shall be as follows:-

### **PEON**

Appointment to the posts of Peon shall be made from the candidates who have passed middle standard examination and possess knowledge of Hindi /Punjabi.

### **SWEEPER**

Appointment to the post of Sweeper shall be made from the candidates having experience of the duties required to be performed. The candidate should be capable of signing in Hindi or Gurmukhi language.

### **AGE LIMIT**

The minimum age limit of a candidate for appointment to the posts of Peon and Sweeper shall be 18 years and upper age limit shall be 42 years as on 01.01.2024 in accordance with the latest instructions of the Haryana Government.
