## 1. Job Description: Full Stack Developer (React Native)

### Job Summary:

The Full Stack Developer will be responsible for the end-to-end development, maintenance, and enhancement of the Poshan Tracker mobile application. The role requires strong technical skills in React Native, API integration, mobile database management, and secure coding practices. The position involves close coordination with technical, functional, and quality assurance teams to support a national-level digital platform.

## Roles and Responsibilities:

- The developer will design and develop mobile application modules using React Native and ensure cross-platform compatibility.
- They will implement responsive UI components, manage state effectively, and integrate RESTful APIs. The role includes mobile development that works in offline mode of using respective technology.
- The developer will participate in code reviews, debugging, performance tuning, and release management.
- They will prepare and maintain technical documentation and work closely with QA teams to support testing and issue resolution.
- Knowledge of DevOps, CI/CD processes, and cloud-based deployments is preferred.
- Knowledge of AI tools for Development, coding, review of Codes is preferable.
